



## **BUILDING ON SUCCESS**

- Voluntary
- Building on the existing foundation of Principals & Criteria
- Standardizing responses to "No Deforestation" policies
- Credible claims of compliance via engagement with accredited 3rd party
- Incorporating concept of Commensurate Effort from the Supply Chain

## **PROCESS**

- Development group appointed by Board of Governors
- Included review of areas where current Guidance exceeded the P&C
- Thematic approach taken
- Conducted 60 day public consultation
  - almost 500 comments received
- Incorporated input from public consultation
- Submitted to the BOG for approval





#### **CONTENT**

#### **No Deforestation**

- Policy
  - The policy shall specify an approach that combines biodiversity & carbon conservation with forest cover assessment and social considerations including community needs.
- Plantings and Carbon Stocks
- Manage and Monitor Direct & Indirect Impacts

#### **No Planting on Peat**

- Of any depth, after 16 November 2015
- When unsuitable for replanting, plans shall be in place for appropriate management or restoration of such areas. Plans will be developed in conjunction with affected communities.

#### **CONTENT**

#### No Use of Fire

- Prevent & Control
  - There shall be no use of open burning/fire in new or ongoing operations for land preparation, land management, waste management, or any other reason other than justified and documented cases of Phyto-Sanitary emergencies. Prior approval must be obtained from appropriate authorities in these cases.

#### **Reduce Greenhouse Gases**

- Measure
  - using RSPO Palm GHG Tool or other approved equivalent.
- Reduce
- Report
  - At organization and MU levels
  - Public & Annual
  - From benchmark year of 2005 and
  - Intensity per tonne by product

## **Respect for Human Rights**

- Fair treatment of Smallholders
- Preventing Conflict
- Land Use is Free of Conflict
- Fair Labour
  - Develop a Decent Living Wage approach
  - Prohibition on use of Paraquat

#### **CONTENT**

#### **Transparency**

- Provide Information to Stakeholders
- Code of Ethics and Integrity
- Traceability from Plantation to Mill
  - Year 1 develop a plan to identify the source of all FFB
  - Year 2 identify the source of all FFB
  - Year 3 all FFB is from known sources in compliance with policy
    - Particular support to be given to smallholders to ensure they are able to meet the requirements. Coordination of HCV and Smallholder approaches by RSPO to be a priority and exclusion of small holder supply to be a last resort.

#### **APPLICATION**

- Requires an organization wide commitment
- Organizational and Management Unit requirements
- On the ground audit of compliance
- •Must be at least 60% P&C Certified before engagement in NEXT permitted

#### **COMMENSURATE EFFORT**

- Requires an equivalent effort from supply chain members
  - 100 CSPO (physical and/or credits) before claiming RSPO NEXT with a plan for moving to physical and/or SmallHolder credits
- Additional commitments to uptake of NEXT
- Uptake to occur directly between Manufacturer/Retailer and Growers
